Re: Notice of meeting to discuss potential rezoning of a portion of five parcels, located southeast of the intersection of Ridge Road and Pickett Road, containing approximately 16 acres, and having Durham County Parcel Identification Numbers 138783 (3117 Pickett Road); 138786 (3121 Pickett Road); 138788 (3127 Pickett Road); 138784 (3107 Pickett Road); and 138789 (3123 Pickett Road) (the "Property").

We are counsel for a developer which is considering rezoning the above-captioned Property to facilitate the development of a residential multifamily community. The entire assemblage is highlighted in red on the context map mailed with this notice, but the rezoning may encompass all or a portion of that entire area. The parcels highlighted in green on that map are within 1,000 feet of the Property. We have attempted to mail this notice to owners and occupants of those parcels within 1,000-ft of the Property.

Currently, the Property is zoned Residential Suburban 20 (RS-20). The developer is considering rezoning it to a Planned Development Residential (PDR) with a density that will allow a maximum of 150 dwelling units. The rezoning will facilitate the development of a residential multifamily community upon the Property.

We will hold a virtual neighborhood meeting on Monday, February 27, 2023, from 6:00 P.M. to 7:00 P.M. via Zoom. The purpose of the neighborhood meeting is to ensure that nearby property owners are made aware of the proposed project and can inform us of their questions or comments. We hope this will help us understand how this project could impact you.


Instructions for registering for and joining the meeting are enclosed.
